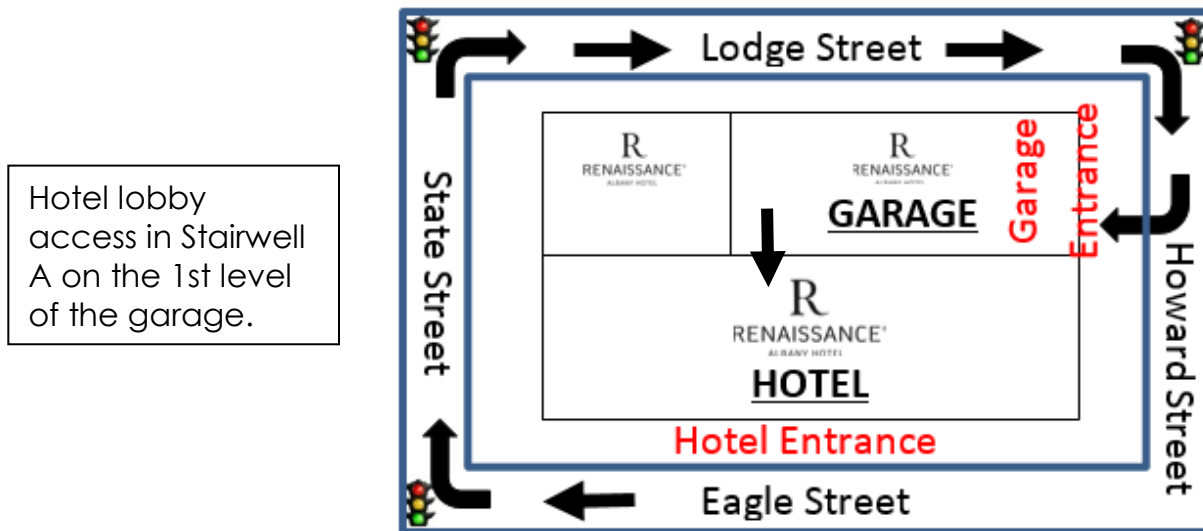

Directions to the Renaissance Parking Garage: Self-parking is available for overnight & event guest in the **Renaissance** parking garage.
